In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 1000 tCO2e by 2028. This represents a reduction of over 70%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented already.

Although 2023 is the baseline year for measuring emissions, we estimate retrospectively that the carbon emissions reduction achieved by these schemes equate to up to 15,000 tCO2e, an 82% reduction against the 2023 baseline, and these measures will be in effect when performing the contract.

- Reduction in office space for head office operations
- · Increased home/remote working
- · Cycle to work scheme
- Season ticket loans
- Reduced business travel

In the future we hope to implement further measures such as:

- · Carbon offsetting initiatives
- Continued focus on balancing office and remote working needs
